

What is GutterClear?



GutterClear:

- accredits contractors;
- standardised spec, terms & conditions
- markets service to parishes & other denominations

Contractor:

- quotes price to parish
- clears all gutters & downpipes
- reports obvious defects
- invites architect

• Church:

pays contractor: median is £300 & VAT



Why is GutterClear needed? (1)







- Few parishes can do it themselves
- Complex fabric; inadequate access & drainage
- Lots of advice –but no incentives, grants etc
- Limited understanding of consequences of failure
- Cost and VAT on top!
- More...



Why is GutterClear needed? (2)







- Health & safety concerns
- contractors
- Low status
- Quinquennial system



GutterClear in action









- Launched 2007
- 3 contractors; 1 builder
- Approx 25% churches; other DIY or other contractors
- "early bird" grant scheme 2008
- Special measures



Why GutterClear Works








- Makes preventive maintenance easier
- Promotes but doesn't subsidise
- Scaleable
- low startup & management costs
- Uses marketing techniques






- 1998: Maintain formed
